



Gold Rush Promotion Terms & Conditions

Definitions

“Bonus” means \$300.00 which can be received by participating in this Promotion and fulfilling its requirements and credited to the Client’s balance subject to these Terms.

“Company” means ForexVox (Seychelles) Financial Services Ltd, incorporated and registered under the laws of Seychelles with Company number 8430368-1 and having its registered address at CT House, Office 9A, Providence, Mahe, Seychelles. The Company is authorized and regulated as a Securities Dealer by the Financial Services Authority under Securities Dealer license number SD142.

“Promotion” means MarketsVox Gold Rush promotion, terms and conditions for which are described in these Terms.

“Terms” means these Gold Rush Promotion Terms & Conditions.

“Trading Period” means a 30 day period the Client has from the date the Company receives and email with 'Start GoldRush' in the subject in order to fulfil the requirements of the Promotion, subject to these Terms.

1. Introduction

1.1. ForexVox (Seychelles) Financial Services Ltd. is a Company incorporated and registered under the laws of Seychelles with Company number 8430368-1. The Company is authorized and regulated as a Securities Dealer by the Financial Services Authority under Securities Dealer license number SD142.

1.2. These Terms shall supplement and make an integral part of the Client Services Agreement. All capitalized terms not defined in these Terms shall have the same meaning as in the Client Services Agreement. All matters not covered by these Terms shall be resolved according to the Client Services Agreement.

2. Specific Promotions Terms

2.1. The Promotion is a limited in time special offer, organized and run by the Company, where the Client can receive a prize while trading XAUUSD subject to these Terms.

2.2. By taking part in the Promotion the Client can receive a Bonus of \$300.00 credited to his trading account after certain requirements listed below are fulfilled.

2.3. The term of this Promotion shall be 09 October 2023 - 31 December 2023.

2.4. The Promotion is available only for clients residing or, in case of legal entities, formed, incorporated or domiciled in Vietnam, Malaysia, Indonesia.

2.5. Promotion is available to all existing and new clients of the Company who have at least one trading account with the company and deposited at least \$1000.00 to such trading account in one or more deposit transactions and have not traded with these funds yet. The deposits shall be made after the start of the term of this Promotion.

2.6. After funds are deposited to the trading account, in order to take part in the Promotion the Client shall contact the Company via support@marketsvox.com and indicate 'Start GoldRush' in the subject of the email. After the Company receives such email, the Client is considered to be taking part in this Promotion and by sending such email the Client acknowledges that he has read, understood, and accepted these Terms.

2.7. From the date and time the Company receives such email with 'Start GoldRush' in the subject, the Client will have 30 days Trading Period to fulfil the below requirements in order to receive the Bonus. The Client shall trade at least 18 standard lots on Standard account type or 30 standard lots on ECN account type on XAUUSD trading instrument only.

2.8. During the Trading Period the Client can trade on other instruments, but only turnover on XAUUSD shall be calculated in the required volume for the purposes of this Promotion.

2.9. Any turnover or orders open on XAUUSD instrument before the Company receives an email with 'Start GoldRush' in the subject and before the Trading Period shall not be calculated in the required volume for the purposes of this Promotion.

2.10. During the Trading Period any deleted or pending (limited) orders, fully or partially

hedged positions, trades copied via the copytrading, closed position has less than 50pips profit or loss or trades with duration less than 60 seconds shall not be calculated in the required volume for the purposes of this Promotion.

2.11. When the client fulfils mentioned requirements during the Trading Period and during the term of this Promotion, the Client shall contact the Company via support@marketsvox.com and indicate 'End GoldRush' in the subject of the email which shall indicate the end of the Trading Period.

2.12. After the Company receives such email with 'End GoldRush' in the subject, the Company will check whether the client was eligible to participate in the Promotion, and in case if the Client is, the Company shall credit the Bonus to the Client's balance of the trading account which took part in the Promotion. These funds shall be added directly to the balance and will be available for trading or withdrawal without any limitations, subject to the Client Services Agreement and Promotion rules.

2.13. If the Trading Period has started during the term of this Promotion, but ended after the Terms of this Promotion, the Client will still be eligible to claim the Bonus if the requirements are fulfilled within 30 days from the start of the Trading Period. For example: the Client has sent and the Company receives an email with 'Start GoldRush' in the subject on 28.12.2023. The Client will have 30 days from that date to fulfil the requirements and can then claim the Bonus.

3. General Terms

3.1. Please note that it might take up to 48 hours for the Company to credit the Bonus to the trading account. During this period the Company might request the Client to complete an additional liveness verification check. The Company shall not credit the Bonus if the Client refuses to complete liveness verification check.

3.2. The Company reserves the right to refuse to credit the Bonus to the trading account to the Client in case if there was any trading activity on the account after the deposit of the required amount but before the start of the Trading Period.

3.3. No bonuses shall be applied to the trading accounts participating in the Promotion. While there is any active Bonus (Deposit, Floating, Welcome) on the trading account, such trading account shall not be eligible to participate in the Promotion and the Company will not credit the Bonus to such trading account after the Trading Period.

3.5. Volumes on trading accounts participating in the Promotion will result in usual Remuneration paid to Introducing Broker who referred the Client, if any.

3.6. Only one trading account can participate in the Promotion at a time. The Client can participate in the Promotion more than once, but only one Trading Period can be started in each calendar month during the term of this Promotion up to the total of three (one in October, one in November and one in December). All requirements must be fulfilled before the start of each Trading Period, including in terms of minimum deposit. If any information of the Client obtained during the registration and verification, including but not limited to name, phone, address, IP address, device, matches with other Client, the Company might consider this as a violation of these Terms. The Company might at its sole discretion consider as a violation of these Terms if a trading account of the Client's representative, close family member, affiliate or affiliated entity, affiliated entity's

directors or representatives is participating in the Promotion at the same time with the Client's.

3.7. The Company reserves the right to cancel the results of this Promotion and debit credited Bonus as well as any or all trading results during the Trading Period, any Remunerations, rebates or cashbacks or any payments resulting thereon upon finding that the Client violates terms and conditions of these Terms or Client Services Agreement, or is involved in any suspicious or fraudulent activity, including but not limited to registering multiple accounts with sole purpose of gaining more Bonuses, making any form abusive trading, risk-free arbitrage, market manipulation, abusing technical features of Company's trading platform or other systems, or any types of risk-free activities aimed at benefiting from or exploiting the Promotion without any economical reason or trading with bearing usual market risk. The Company will resolve such cases at its sole discretion.

3.8. If cancelling the results of this Promotion for any reason would cause the margin to exceed the Client's own funds, the Company reserves the right to close any open positions at then-current market prices.

3.9. Any situation not described in these Terms shall be subject to the Company's decision. The Company reserves the right to change, amend, update, or cancel these Terms at any time at its sole discretion by posting an updated version on the website. By continuing to participate in the Promotion the Client agrees with any changes, amendments or updated to these Terms. The Company reserves the right to reject participation or disqualify a Client from participation in this Promotion at any moment without explaining the reason. Clients who have been rejected or disqualified lose their right to claim the Bonus.

4. Risk Warning
